

# Privacy Policy

## **When does this Privacy Statement apply?**

This Privacy Statement explains the approach taken by “Gogarty’s” (collectively, “we” or “us”) toward the personal information and data about you (“Your Information”) that we collect when you use this Website. It does not apply to information we collect in other ways e.g. when you are dealing with our staff in Gogartys or over the telephone. In these cases, there may be other statements and terms and conditions that are applicable.

This Privacy Statement is also limited to information and data collected on this Website. There are links from this Website to other parts of the Internet that we do not operate or control and our Privacy Statement does not apply when you leave our Website.

## **You consent to our use of Your Information and Cookies**

By using this Website and/or providing Your Information you consent to: (1) our use of Cookies and our use of Your Information as described in this Privacy Statement; and (2) the terms and conditions of this Privacy Statement.

If you do not consent then please do not proceed further and do not provide any personal information or data.

## **What information do we collect about you?**

The Website is designed to use Cookies to collect information about how people use the Website (see Use of Cookies) and in some places we specifically ask you for personal information. Otherwise, you can use the Website without providing information and data about yourself.

## **Use of Cookies**

Cookies are small data files that our web server sends to your web browser when you visit certain parts of our Website. We use cookies and related technologies to:

- allow our web server to determine whether the cookies setting on your web browser has been enabled or disabled so that we will know whether data can be collected from your web browser.
- temporarily identify you after you have logged in to a secure page on our Website so that our web server can maintain a dialogue with your web browser in order for you to carry out certain activities.
- temporarily allow you to carry information between pages of our Website to avoid having to re-enter that information.

These cookies do not collect or store your name, address or other personal information. Most web browsers are initially set up to accept cookies. You can choose to ‘not accept’ cookies by changing the settings on your web browser but if you do this you may find that certain features on our Website, including Online Banking, do not work properly.

**We would also like to use cookies to:**

- store your selected login preferences so you do not have to re-select that option when you return to the Website.
- track your visits to our Website and recognise your web browser when you are a repeat visitor so that we can gather statistics on the number of new and repeat visitors and evaluate site effectiveness.
- temporarily store information on your link preferences and your movement between web pages to help us to improve the Website and provide a more useful experience.

**Online Products**

There are sections of the Website where we ask for personal information, for example, when you complete online forms to apply for a particular product or service or if you register to use our secure online services such as Online Banking. Please ensure you also read the Terms and Conditions applicable to these product and services.

**How we use Your Information**

We will always treat Your Information as confidential. We will use good practices to keep it secure and will otherwise abide by the relevant data protection and privacy laws.

**Marketing**

We do not use information collected on this Website for marketing purposes but your Information may be used to inform you about other products and services that may be of interest. In certain jurisdictions, your consent will be required before we can do this.

**Privacy, security and communications using the Internet**

The Internet is not a secure form of communication and sending and receiving information over the Internet carries with it risks including the risk of access and interference by unauthorised third parties. It is your responsibility to maintain the secrecy of any user ID and login password you hold.
